

Non-O Spouse Thai Visa

Spouse of Thai national

For foreigners who are registered as married to Thais or have Thai children who want to apply for a visa to enter Thailand, you can stay for 90 days and can apply for an extension for 1 year (and subsequent years).

Overview

Create Account → Fill out the form → Upload → Payment →
Receive e-Visa via email. No need to go to the embassy or
send the actual passport.

You can get the visa for 90 days. Once you enter Thailand,
you can contact the immigration office near your home to
apply for a 1-year extension (you can extend it continuously).

How to check if an applicant can apply for a visa online

- Applicants must have residence in that country with evidence such as ID card / Passport / Work permit / Other documents showing that you actually reside in that country.

- Choose “Am I eligible to apply online”

This means that if the applicant resides in these countries, you can apply online, no need to go to the embassy. If you are not in the countries on the map above, you must go to the Thai consulate in the applicant's country.

Checklist

1. Biodata page of Passport or Travel Document : Passport page with applicant's photo
2. Photograph taken within the last six months : Visa photo, you can take it yourself, but the light must be enough, no shadows. There are many applicants have this problem. You should take photos at a booth or ask someone else

to take photos for you. If you have uploaded and paid, the consulate officer may ask you to take a new photo.

3. Document indicating current location : Evidence showing that the applicant is actually resident in the chosen country.

4. Financial evidence showing monthly income of no less than 40,000 THB or having the current balance of 400,000 THB, e.g. bank statements, proof of earnings
You can transfer the big amount immediately and then download the statement and upload it.

5. Personal details of a family in Thailand, e.g. ID card, Passport and the visa page or stay permit in Thailand : Documents of your Thai spouse are the Thai national ID card and house registration.

6. Proof of relationship to a family in Thailand, e.g. A copy of marriage certificate / birth certificate / certificate of adoption : Thai marriage certificate, birth certificate of children with Thai nationality

In the case of not being registered as married to a Thai but having children together, the child's birth certificate can be used to show the relationship with the applicant, or a legal child custody certificate can be used if the child is not a biological child.

Filling out an application

- You should fill the information correctly according to your passport, especially your first and last name. If there are special characters in the local language, spell them according to the English characters because you cannot fill them in the local language
- The way to check is to visit the embassy website, for example ; the Thai Embassy in Oslo, Norway

- First and last name fields should be corrected because once payment has been made, it cannot be changed. If the visa has been issued but the first and last names are in the

wrong position, you need to run the process again and a new fee must be paid.

- You must choose a date to stay in Thailand not exceeding 90 days, but once you have entered Thailand, you can request to extend your stay.
- Fill in the address as it appears on the house registration so that it matches the evidence sent.
- After filling in the informations, uploading documents and paying the embassy fee, some embassies may request additional documents. Please check your email or log in to check regularly.
- No need to buy a ticket before applying the visa, just fill in the flight details.

What is the information in the Visa means

- **Date of Grant 1 October 2024** : This means that you can enter Thailand starting from October 1, 2024.
- **Visa must be used by 1 January 2024** This means that the last day you can enter Thailand is January 1, 2024.
- You can enter on any date from October 1 to January 1, and count 90 days from the date of entry into Thailand. The immigration officer will stamp the date for you.
- Once you enter Thailand, you can apply for a 1-year extension every year as long as you have not left Thailand.

- If you want to leave Thailand before your visa expires, you can do a Re-entry at the airport or at the immigration office near your home. Pay the fee, but you must re-enter Thailand before your visa expires.
- If your visa has expired when you stay outside Thailand, you must apply for a new visa.
- Re-entry is similar to purchasing multiple entry and exit rights to Thailand multiple times until the visa expires.

Suggestions in case of unable to click the link

Try one of the following

1. Recommended to use a PDF reader app: ReadEra, Drive PDF to open video links
